The purpose of this letter is to assist you with the disposition of the charge(s) filed against you. YOU MUST ANSWER FOR THE CHARGE(S) BY MAIL OR IN PERSON, OR THROUGH YOUR ATTORNEY (A TELEPHONE CALL DOES NOT CONSTITUTE AN APPEARANCE.) IF YOU FAIL TO RESPOND TO THE CHARGE(S) BY THE APPEARANCE DATE SHOWN ON THE CITATION, YOU WILL BE CHARGED WITH FAILURE TO APPEAR, WARRANTS WILL BE ISSUED FOR YOUR ARREST (WITH A \$50.00 FEE ASSESSED FOR EACH WARRANT) AND YOU COULD LOSE THE PRIVILEGE TO RENEW YOUR DRIVER'S LICENSE, A JUVENILE WHO FAILS TO APPEAR MAY HAVE THEIR DRIVER'S LICENSE SUSPENDED.

**NOTE:** The Judge cannot discuss the merits of a pending judicial proceeding prior to trial.

### Judge's Ability to Dismiss

The municipal judge is responsible for conducting a fair, impartial, and public trial. The case against you is brought by the State of Texas through the prosecutor, not the court. Therefore, the judge may not dismiss a case without the prosecutor having the right to try the case.

There are several exceptions to this rule, including deferred disposition, driving safety courses, and compliance dismissals.

#### Deferred Disposition

The judge may, in the judge's sole discretion, defer disposition on most cases. The holder of a commercial driver's license (CDL) is not eligible for deferred disposition on moving traffic violations. Costs must generally be paid when the court grants deferred. If you complete the required terms, the case is dismissed, and

the court may impose a special expense fee not to exceed the maximum fine amount authorized by state law. The deferred period cannot exceed 180 days.

IF YOU WISH TO ENTER A PLEA OF GUILTY OR NOLO CONTENDERE, please so indicate on the REPLY FORM on reverse side. A plea of Nolo Contendere means that you do not contest the State's charge(s) against you. The fine for a Nolo Contendere plea is the same as for a plea of Guilty. Either plea indicates that you agree to waive your right to trial. Please call the Court Clerk at above number for fine amount(s).

IF YOU WISH TO ENTER A PLEA OF NOT GUILTY and would like a trial before the Judge or before a Jury, please so indicate on the Reply Form on the reverse side. The Court will notify you when you MUST appear for trial and will advise you of any other required procedures. You must advise the Court of any address change.

of Texas, you may be able to have one moving violation dismissed by taking a Driving Safety Course, HOWEVER, YOU WILL LOSE THAT RIGHT IF YOU DO NOT PROVIDE WRITTEN NOTICE TO THE COURT OF YOUR DECISION TO REQUEST DSC AND PAY ALL FEES ON OR BEFORE YOUR APPEARANCE DATE. You are not eligible for this option if it is a violation of 25 MPH or more above the posted speed limit or 95 MPH, if the offense occurred in a construction zone with workers present, if you hold a CDL License, or if you have completed a DSC under this option within the 12 months immediately preceding the date of the citation. You must have had a valid Texas Driver's License or permit at the time of the citation and show proof of financial responsibility. If you wish to take advantage of this option read and complete the Request Form for DSC and return it to the Court with

the required fee, a copy of your Texas Driver's

License and proof of insurance on or before your appearance date. You will have 90 days, from the date the Court grants permission for the course, to complete an approved DSC.
